The Jammu & Kashmir Pharmacy Act,

Samvat, 2011 (1955 A.D) stands repealed by Pharmacy Act, 1948 in terms of Jammu & Kashmir Re-Organization Act, 2019. The Central Government vide notification issued under 3465(E), Dated: 05th of October, 2020 has incorporated Section 32C in the Pharmacy Act, 1948 which is reproduced as under:

Section 32(C): "Special provisions regarding persons registered under the Jammu and Kashmir Pharmacy Act, Samvat, 2011 (1955 A.D):- Notwithstanding anything contained in section 32, any person whose name has been entered in the register of pharmacists maintained under the Jammu and Kashmir Pharmacy Act, 2011 (1955 A.D) and possesses qualification prescribed under the said Act shall be deemed to have been entered in the register of pharmacists prepared and maintained under Chapter IV of this Act, subject to an application to be made in this behalf within a period of one year commencing from 31st October, 2020 and payment of such fee as may be prescribed by the Government of Union Territory of Jammu and Kashmir."

All those candidates who were holding Registration as Pharmacist under the repealed J&K Pharmacy Act, Samvat, 2011 are hereby informed to get themselves registered under Section 32 C of the Pharmacy Act, 1948 by or before 31st of October, 2021.

Any application in this regard which is received after the above cut off date shall not be considered for Registration as Pharmacist in the Central Act. The applicants are informed to apply as per below link:
