## PUBLIC NOTICE.

The J&K Pharmacy Council has started the process of re-registration of Pharmacists earlier registered under the repealed J&K Pharmacy Act, Samvat, 2011. This process was carried out under Section 32C of the Central Pharmacy Act, 1948 through online portal <a href="www.jkpc.in">www.jkpc.in</a> w.e.f 16.12.2020. Some applicants approached the Council office for out of turn consideration in the Online Portal citing career related exigencies. The Council appreciated the genuine concerns of such applicants and allowed out of turn consideration of such candidates & offered submitting of applications in this regard through email Id's: <a href="mailto:presidentjkpharmacycouncil@gmail.com">presidentjkpharmacycouncil@gmail.com</a> & <a href="mailto:jkpharmacycouncil@gmail.com">jkpharmacycouncil@gmail.com</a>.

The Council office has observed that applicants are filing priority applications through mail without submitting any supportive evidence to suggest any out of turn consideration.

In light of the above situation, it is impressed upon all such applicants that there is no reason to create panic so far as re-registration cut off date i.e, 31st of October, 2021 is concerned. It may be clarified that any applicant who have remitted the applicable fee through the online portal of J&K Pharmacy Council is deemed to have been registered as Pharmacist under Section 32C of the Pharmacy Act, 1948.

All concerned are therefore informed through the medium of this notice to exercise discipline/restraint while exhibiting exigency for out of turn disposal of their re-registration applications.

It may be noted that priority applications sent without any valid reasons / supportive documentary evidence shall be treated as "null".
