SUBJECT

Cancellation /Rejection of Re-registration application of Syed Tanveer Razvi S/o Mr. Syed Rasool Razvi R/o Tantripora, Tangmarg, Distt-Baramulla (under 32C of the Pharmacy Act 1948-regarding).

Whereas, the Pharmacy Council of Union Territory of J&K issued a Public Notice under endorsement no:JKPC-86/Estt/681-91, Dated: 16.12.2020 inviting therein applications for re-registration/validation of Pharmacist Registration certificates of all those persons who were registered as Pharmacist under the repealed J&K Pharmacy Act, Samvat, 2011, (1955, A.D);

Whereas, the above exercise was initiated in pursuance to provisio (32C) incorporated in the Pharmacy Act, 1948 notified vide S.O no: **3465(E), Dated: 05**<sup>th</sup> of October, 2020;

Whereas, the above applicant namely Mr. Syed Tanveer Razvi S/o Mr. Syed Rasool Razvi R/o Tantripora, Tangmarg, District-Bandipora) uploaded an application in the Online Portal of J&K Pharmacy Council for re-registration under (32C) of the Pharmacy Act, 1948 vide Form reference no: PHAR021842, Dated: 28.10.2021;

Whereas, after perusal of office records/scrutiny of uploaded documents following discrepancies were observed;

- That the registration number: <u>11883</u> mentioned in the uploaded certificate actually belongs to <u>Mr. Ali Mohd Malik S/o Mr. Nisar Ahmad Malik R/o</u> <u>Dangerpora, Pattan, Baramulla;</u>
- That the registration certificate has not been prepared/ signed by any of the Office bearers of the Council;
- III. That the signature of issuing authority also does not belong to any one of the competent authorities who have discharged functions as President in the Council;

Whereas, the observations highlighted herein above suggests that the above person has adopted unfair means by uploading fake documents/credentials;

Whereas, the above person was offered an opportunity to provide his response in the matter through show cause/personnel appearance notice vide this office letter bearing no: JKPC/SCN/2023/PHAR021842/2632-37, Dated: 24.01.23;

Whereas, the applicant was once again afforded an opportunity through a Final notice for personal appearance vide this office letter no: JKPC/SCN/2023/PHAR021842/2632-37, Dated: 01.03.2023;

Whereas, reply received from the applicant's side has been examined & found devoid of any merit;

Now, therefore the undersigned in exercise of powers vested under Section (41) of the Pharmacy Act, 1948 rejects the application of the applicant for re-registration as Pharmacist in terms of Section 32(C) of the Pharmacy Act, 1948 & imposes a penalty of Rs. 500/- (First conviction) to be deposited in the bank account of J&K Pharmacy Council bearing bank details:
