## CIRCULAR.

Whereas, the Pharmacy Council of Union Territory of J&K issued a Public Notice under endorsement no: JKPC-86/Estt/681-91, Dated: 16.12.2020 inviting therein applications for registration as Pharmacist under Section 32 of the Pharmacy Act, 1948 on the basis of having undergone Courses of study in Pharmacy as per the Education Regulations notified by the Apex body, i.e Pharmacy Council of India from time to time;

Whereas, the above exercise was initiated in pursuance to J&K Pharmacy Rules, 2020 notified vide S.O no: 347, Dated: 13th of November, 2020;

Whereas, the J&K Pharmacy Council is receiving applications from applicants through online portal;

Whereas, after scrutiny/examination of applications, it has been found that some of the Universities / Institutions have issued Diploma/Degree(s) in Pharmacy certificates to some of the candidates in non-attending mode as also without taking into account the eligibility criteria in so far as age, subjects, duration of course, session, intake capacity etc is concerned;

Whereas, it has also been observed that various universities are running their off-campus classes from unregistered study centres located across Jammu & Kashmir without obtaining necessary approval from the competent authority;

Whereas, several complaints have been received by this office alleging that some Universities are providing certificates of having qualified various courses of study in Pharmacy to such candidates who have neither undergone any study nor visited the institutions;

Whereas, the Council as a matter of procedure and practice is referring the eligibility documents of the applicants to the issuing/examining authorities of the concerned institution/university for verifying & ascertaining the genuineness of the credentials purportedly issued by them;

Whereas, amidst allegations of unfair practices being resorted to by certain institutions, the Council as an abundant precaution has decided to obtain batch-wise list (since start of course till date) of all pass out candidates particularly belonging to the U.T of J&K who have completed their Diploma/Degree(s) courses in Pharmacy from the concerned institutions/universities along with admission records as per below format:
