- 07	Cancellation/Rejection of registration application of Mr. Mansoor ul Bashir S/o Mr. Bashir Ahmad Rather R/o Chandara, Pampore, Distt-Pulwama (under 32 of the Pharmacy Act, 1948-regarding).

Whereas, the Pharmacy Council of Union Territory of J&K issued a Public Notice under endorsement no: JKPC-86/Estt/681-91, Dated: 16.12.2020 inviting therein applications for registration as Pharmacist under the Pharmacy Act, 1948;

Whereas, the above exercise was initiated in pursuance to the implementation of the Pharmacy Act, 1948 in the Union Territory of Jammu & Kashmir after the enforcement of J&K. Re-organization Act, 2019;

Whereas, an application for registration as Pharmacist under Section 32 of the Pharmacy Act, 1948 from Mr. Mansoor ul Bashir S/o Mr. Bashir Ahmad Rather R/o Chandara, Pampore, Distt-Pulwama was uploaded in the Online Portal vide Form reference no: PHAR002637, Dated: 18.05.2021 along with below documents (Whichever is applicable):

Whereas, as a matter of practice & procedure, the eligibility certificate uploaded by the said applicant was referred to the concerned university/examining body for purpose of verifying its genuineness;

Whereas, a communication presumably originating from Manay Bharti University, Solan, Himachal Pradesh was received by the J&K Pharmacy Council on 17.11.2022 & 29.07.2022 which was taken on record & the application submitted was approved & the registration as Pharmacist was granted in his favour as per below details:

Whereas, the initiating official entrusted with scrutiny & processing of applications uploaded through online portal found that there is an element of suspicion about the credentials of applicant's eligibility;



Whereas, the above inputs were taken on record & as an abundant precaution, a confidential exercise was initiated with the competent authority of Manay Bharti University, Solan, H.P who responded vide their communication with below text:

"This is with reference to your letter no. JKPC-Estt/2574-76 dated 05 Jan. 2023. In this regards it is submitted that communication no: MBU/Ref./2022/4836, Dated: 17.11.2022 is not issued by Manav Bharti University."

Whereas, the response highlighted herein above clearly indicates that the claims of eligibility by the applicant are not bonafide & further the said person has indulged in unfair means;

Whereas, at the time of filing the application through online portal, the applicant has also submitted an affidavit duly sworn before 1st Class Judicial Magistrate, Pampore with one of the below averments:

"That in the event, my eligibility for registration as Pharmacist is found to have been acquired through misrepresentation, impersonation or concealment of material facts and found false, the Pharmacy Council shall have a right to strike off my registration as Pharmacist ab-initio without providing me any opportunity for being heard".

Whereas, the above person was offered an opportunity to provide his response in the matter through show cause notice vide this office letter bearing no: JKPC/SCN/2023/PHAR002637/608-621, Dated: 07.08.23;

Whereas, no reply was received from the applicants end;

Whereas, the applicant was once again afforded an opportunity to provide his response through a vide this office Appearance notice /Personal CBUSC JKPC/SCN/2023/PHAR002637/812-824, Dated: 01.09.2023;

Whereas, the applicant has failed to respond to the communications reflected in para supras and therefore the applicant has not availed of his right to be heard before a decision in the matter is taken.

Now, therefore the undersigned in exercise of powers vested under Section (36) of the Pharmacy Act, 1948 rejects the application of the applicant for registration as Pharmacist in terms of Section 32 of the Pharmacy Act, 1948 with immediate effect.
