Whereas, several applicants have uploaded their applications for grant of registration as Pharmacist on the basis of claiming to have qualification acquired as Diploma/Degree in Pharmacy from OPJS University, Churu, (Rajasthan);

Whereas, as a matter of practice, the verification process for uploaded applications was initiated by the council;

Whereas, the Jammu and Kashmir Pharmacy Council initiated separate correspondence with the subject university vide this office letter no: JKPC-Estt-2350/2436, Dated:12.03.2026 & JKPC-Estt-134-138, Dated: 02.06.2026 seeking response to below points:

- i. Cross verification of List of candidates (session -wise) received by this office from time to time from the OPJS University, Churu, Rajasthan
- ii. Status of approval from the Pharmacy Council of India under section (12 of the Pharmacy Act, 1948-Year wise).
- iii. Exact intake capacity in Diploma/Degree courses as per authorization of the competent authority with documentary evidence.
- iv. Number and List of candidates belonging to the U.T of J&K who have been enrolled in your esteemed institution/university, since the inception of the Pharmacy courses (Year wise).

- v. **Name of the authorised authority presently responsible for conducting the business of the institution/University along with his/her specimen signatures.;**

Whereas, as an abundant precaution a notice was issued & uploaded in the official website of the council which reads as under:

"till such time, the matter is settled in its right perspective, the Jammu & Kashmir Pharmacy Council shall not be in a position to process/dispose of the pending applications pertaining to the subject university.;

Whereas, the above action was necessitated for the reason that this council staff observed certain noticeable discrepancies in the individual communications received in response to correspondence from this council & purportedly originating from the principle university i.e OPJS University, Churu, (Rajasthan);

Whereas, the Registrar of the OPJS University, Churu, Rajasthan vide his communication/mail no: OPJS/026/401, Dated: 24.06.2026 through mail Id: (registrar@opjsuniversity.edu.in) submitted the below clarification in response to this office communication no: JKPC-Estt-134-138, Dated: 02.06.2026 which is reproduced as under:

Sir,

In compliance with your request for an early response and to prevent unnecessary applicant harassment, the point-wise consolidated clarification regarding both of your above-referred letters is submitted as follows:

PART-A: Information sought vide your letter dated 02.06.2026

1. Status of Approval from Pharmacy Council of India:

As per the order of the State Government, the Divisional Commissioner, Bikaner has been appointed as Administrator of the University. Due to administrative restructuring, OPJS University, Churu does not have approval from the Pharmacy Council of India under Section 12 of the Pharmacy Council of India Act, 1948 for any Pharmacy course after the 2023-24 academic session (As per PCI website). At present, no Pharmacy course of the University is approved by PCI. The year-wise details are Nil.

2. Intake Capacity:
At present, no Intake Capacity for conducting Pharmacy courses has been sanctioned by the competent authority. Hence, the details are Nil.

3. Number/List of Candidates from J&K UT:
We are consolidating the data, so we are unable to provide the details you sought.

4. Name of Currently Authorized Officer & Specimen Signature:
From 08/01/2026 to the present, no officer has been duly authorized/nominated for

document verification/academic work in the University. Hence, providing a specimen signature is not possible.

PART-B: Clarification regarding your letter dated 12.03.2026 & "Suspected Proxy Element"

5. Examination of Previous Correspondence Enclosed with Your Letter: The 6 previous communications enclosed with your letter dated 12.03.2026 have been examined. Communications at Sl. No. 1 to 5 pertain to the period prior to 08/01/2026. After the appointment of the Administrator on 08/01/2026, the process of re-verification of all records is underway. Therefore, the authenticity of the said old letters can only be confirmed after verification of records.

6. Regarding Forged Letter No. ADMIN/OPJS/VC/429/2346, Dated: 12-01-2026: This letter, mentioned in your enclosures, is specifically brought to your notice. From 08/01/2026 to the present, the University has not verified any student related to Pharmacy courses, nor has it authorized any person been authorized for this purpose. Therefore, it is hereby clarified that Letter No. ADMIN/OPJS/VC/429/2346 dated 12-01-2026 has NOT been issued by OPJS University. This letter is completely fake, forged, and illegal, and the University shall not be responsible for it.

7. Clarification on "Suspected Proxy Element" & Delay: With regard to the "suspected proxy element" mentioned in your letter dated 02.06.2026, it is clarified that any verification certificate issued in the name of OPJS University by any person or institution from 08/01/2026 to the present date shall be considered fake. Regarding the delay in disposal of applications, it is submitted that the appointment of the Administrator and administrative restructuring is a legal process initiated by the State Government, which is currently in progress.

Conclusion: Therefore, you are requested to treat any Pharmacy verification certificate issued in the name of OPJS University, Churu after 08/01/2026 up to the present date as invalid and to keep further action on such applications in abeyance. You shall be duly informed once the verification process is re-initiated by the competent authority.

All students, parents, and stakeholders are hereby informed that due to serious irregularities and maladministration prevailing in OPJS University, Churu, the Department of Higher Education (Group-4), Government of Rajasthan, Jaipur, vide Order No. F.3(9) Shiksha-4/2014 Part-03293 dated 07/01/2026, dissolved the management of OPJS University, Churu and appointed the undersigned as the Administrator of the University.

After assuming charge as the Administrator on 08/01/2026, the University was sealed. Subsequently, vide Order No. 26 dated 23/01/2026, it was directed

that:

- No authority of OPJS University, Churu shall issue any document.
- Verification of any documents previously issued by the University shall remain completely prohibited.

However, it has come to the notice of the undersigned that certain unauthorized persons/groups are still illegally issuing fake mark sheets and degrees in the name of OPJS University, Churu, and are also carrying out verification of previously issued documents.

In this regard, the Registrar of OPJS University, Churu has lodged FIR No. 94/2026 at Police Station Hamirwas, District Churu, and the matter is under investigation.

Accordingly, all concerned are once again informed that all documents issued or verified by OPJS University, Churu after 08/01/2026 shall be treated as illegal and invalid.

All students, parents, stakeholders, and concerned persons are hereby informed that due to serious irregularities and mismanagement prevailing at OPJS University, Churu, the Department of Higher Education (Group-4), Government of Rajasthan, Jaipur, vide Order No. F.3(9) Education-4/2014 Part-03293 dated **07.01.2026**, dissolved OPJS University, Churu and appointed the undersigned as the **Administrator** of the University.

After assuming charge as Administrator on **08.01.2026**, the undersigned took over the management of OPJS University, Churu. Subsequently, vide **Order No. 26 dated 23.01.2026**, a complete prohibition was imposed on the issuance of any documents by any authority of OPJS University, Churu, as well as on the verification of documents previously issued by the University.

However, it has come to the notice of the undersigned that certain unauthorized individuals/groups are still carrying out verification of documents in the name of OPJS University, Churu. In this regard, an **FIR No. 94/2026** has been registered by the University's Registrar at **Hamirwas Police Station, District Churu**, and the matter is

under investigation.

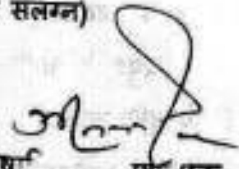
