
Whereas, in response to the above communication, reply received from the concerned university, the operative para of which is reproduced as under:

In light of the contents of foregoing paras and before taking any final action in the matter, you are hereby afforded an opportunity to furnish your response and comments in the matter in writing to the undersigned through return mail or physically by or before one week after the receipt of this communication, positively;

It may be noted that in the event of your failure to respond to this notice, the council shall be constrained to initiate ex-parte action against you.
