Whereas, the Pharmacy Council of Union Territory of J&K issued a Public Notice under endorsement no: JKPC-86/Estt/681-91, Dated: 16.12.2020 inviting therein applications for registration as Pharmacist under the Pharmacy Act, 1948;

Whereas, the above exercise was initiated in pursuance to the implementation of the Pharmacy Act, 1948 in the Union Territory of Jammu & Kashmir after the enforcement of J&K re-organization Act, 2019 ;

Whereas, an application for registration as Pharmacist under Section 32 of the Pharmacy Act, 1948 from your end was uploaded in the Online Portal vide Form reference no: PHAR015511, Dated: 26.06.2025 along with below documents (Whichever is applicable):

Whereas, as a matter of practice & procedure, the eligibility certificate with regard to (Senior Secondary School-12th certificate) uploaded from your end was referred to the concerned university/examining body (National Institute of Open Schooling, Noida for purpose of verifying its genuineness;

Whereas, in response to the above communication, reply received from the concerned university, the operative para of which is reproduced as under:

"This has reference to letter no: JKPC/VERF/10+2/PHAR015511, Dated: 27.10.2025 (Letter received on dated 23/12/25) on the subject cited above. In this connection, it is to inform you that as per NIOS exam data record above stated roll number and data does not exist and the other verification report (Genuine Report dated 08/12/2025) sent by you has not been issued by the NIOS, it is completely fake".

Whereas, the above chronology of events clearly indicates that you have indulged in unfair means and submitted fictitious documents w.r.t (Senior Secondary School-12th certificate) by resorting to manipulation and misrepresentation/impersonation;

Whereas, you have been offered an opportunity to provide your response in the matter through show cause notice vide this office letter bearing no: JKPC/SCN/2026/PHAR015511|Estt-2361-2368, Dated-12.02.26

Whereas, till date no reply was received from your end;

Whereas, you have failed to respond to the communications reflected in para supras and therefore you has not availed of your right to be heard before a decision in the matter is taken.

Hence, your application for registration as Pharmacist is therefore rejected.
